4.1. Description of first aid measures

GENERAL INFORMATION

6.1. Personal precautions, protective equipment and emergency procedures

Block the leakage if there is no hazard.

6.2. Environmental precautions

7.1. Precautions for safe handling

Keep away from heat, sparks and naked flames; do not smoke or use matches or lighters. Do not eat, drink or smoke during use. Remove any contaminated clothes and personal protective equipment before entering places in which people eat. RESPIRATORY PROTECTION
